This policy is intended to protect the health of the people served by this water system by preventing contaminants from flowing backwards into the water supply. Compliance with OAR 333-061-0070 through -0074 will be accomplished through adoption of the following rules which include installation, maintenance and testing of backflow prevention devices and assemblies as well as complying with other rules to report backflow data to the Oregon Health Authority every year.

Actual or potential cross connections are prohibited. If a potential exists for a cross connection the water system must be protected by an appropriate backflow prevention device or assembly.

Hunnell Hills Community Water System (HHCWS) has the right to refuse or terminate water service to any member who does not install a backflow device or assembly when required, including at least annual testing and any necessary repairs.

HHCWS reserves the right to demand a backflow device at the member's side of the water meter if access is not allowed to determine if a backflow device is necessary.

HHCWS will allow reasonable time to comply with our rules. However, should a backflow incident occur HHCWS has the right to immediately terminate service and only restore service following compliance.
