

Enabling Ordinance or Enabling Authority For Small Water Systems

Water System Name: Mobile Village LLC MHP

Water System PWS ID#: 4100984

Date of Water System approval of this document 2015

The purpose of this ordinance is to protect the health of the people served by this water system here at Mobile Village by preventing contaminants from flowing backwards into the water supply. To accomplish this, these rules are in compliance with OAR 333-061-0070 thru 333-061-0074. This includes installation, maintenance and testing of the backflow prevention device and assembly, located at 13045 Se stark street off of third street. (Map included).

Actual and cross connections are prohibited. If a potential exists for a cross connection and this is necessary, the water system will be protected by an appropriate backflow prevention device and assembly. * There are "NO" High Hazards here at Mobile Village. The only backflow device is installed at the city main water line connection to the water system and is kept closed at all times and should only be opened if the ground small water system should fail due to ground water contamination and/ or the failure of the well pump system.

The current backflow device is regularly monitored by management, inspected annually by a professional backflow testing inspector (Water Metrics), and is recorded and catalogued with any and all findings or repairs made. Mobile Village also records any and all complaints filed by any tenants for unusual water complaints and repairs that may be needed to the well water system. (Repair and complaint log mincluded.)

Mobile Village has the right to refuse or terminate water service to any customer who does not install a backflow device or assembly, when necessary. Testing annually is required.

Mobile Village will allow a reasonable time to achieve compliance with our rules, but should a backflow incident occur, the water

system has the right to terminate service immediately and restore it only after compliance.
