RESOLUTION NO. 2022-1 41-01547

A RESOLUTION of the Charlotte Ann Water District, Board of Commissioners regarding the adoption of the Enabling Authority necessary to be in compliance with Oregon Administrative Rules (OARs) 333-061-0070 through 333-061-0074 as required by the Oregon Health Authority Drinking Water Services.

WHEREAS Charlotte Ann Water District is an Oregon Special Water District duly formed pursuant to ORS Chapter 198 and ORS Chapter 264, and subject to state-mandated water quality requirements imposed by Oregon Health Authority Drinking Water Services.

WHEREAS Oregon Health Authority Drinking Water Services has noticed the District that in order to be in compliance with Oregon Administrative Rules (OARs) 333-061-0070 through 333-061-0074 the District is required to establish an enabling authority that authorizes discontinuing water service to premises for:

- (A) Failure to remove or eliminate an existing unprotected or potential cross connection;
- (B) Failure to install a required approved backflow prevention assembly;
- (C) Failure to maintain an approved backflow prevention assembly; or
- (D) Failure to conduct the required testing of an approved backflow prevention assembly to at each service within the District.

WHEREAS the Charlotte Ann Water District Board of Directors has determined it is in the best interests of the District to protect the health of the people served by this water system by preventing contaminants from flowing backwards into the water supply.

NOW, THEREFORE BE IT RESOLVED:

The Charlotte Ann Water District hereby adopts the following:

1. Actual or potential cross connections are prohibited. If a potential exists for a cross connection the water system must be protected by an appropriate backflow prevention device or assembly.  
Any high hazards, as specified in the OARs will be given the highest priority, and protected with an approved air gap or reduced pressure backflow assembly.
2. The water system has the right to refuse or terminate water service to any customer who does not:
  - a. Install a backflow device or assembly, when an actual or potential cross connection exists.
    - a. The water system reserves the right to require a backflow device at the customer's side of the water meter if access is not allowed to determine if a backflow device or assembly is necessary
  - b. Test the assembly at least annually and complete necessary repairs
    - a. When a backflow assembly is tested and it fails the test, the assembly must be repaired or replaced and then tested again.

.The water system will allow a reasonable time to achieve compliance with our rules, but should a backflow incident occur, the water system has the right to terminate service immediately and restore it only after compliance.


3. A list of all high hazard connections and how they are protected from a cross connection is attached to this enabling authority.

This enabling authority is approved and adopted and will remain in effect as of this date until such time as revised or eliminated.
