Enabling Authority

Purpose The purpose of this ordinance is to protect the health of the people served by this water system by preventing contaminants from flowing backwards into the water supply. To accomplish this, these rules are in compliance with Oregon Administrative Rules (OARs) 333-061-0070 through 333-061-0074.				
Requirements Actual or potential cross connections are prohibited. If a potential exists for a cross connection the water system must be protected by an appropriate backflow prevention device or assembly.				
Any high hazards, as specified in the OARs will be given the highest priority, and protected with an approve air gap or reduced pressure backflow assembly.				
 Enforcement The water system has the right to refuse or terminate water service to any customer who does not: Install a backflow device or assembly, when an actual or potential cross connection exists. Test the assembly at least annually and complete necessary repairs 				
The water system reserves the right to require a backflow device at the customer's side of the water meter if access is not allowed to determine if a backflow device or assembly is necessary.				
The water system will allow a reasonable time to achieve compliance with our rules, but should a backflow incident occur, the water system has the right to terminate service immediately and restore it only after compliance.				
Additional A list of all high hazard connections and how they are protected from a cross connection is attached to this enabling authority.				
This enabling authority is approved and adopted and will remain in effect as of this date until such time as revised or eliminated.

We're very please to provide you with this year's Annual Quality Water Report. We want to keep you informed about the excellent water and services we have delivered to you over the past year. Our goal is and always had been, to provide to you a safe and dependable supply of drinking water. Our water source is Wells Drawn from the Wilsonville Aquifer.

I'm pleased to report that our drinking water is safe and meets federal and state requirements for the period of 01-01-21 to 01-01-22.

We have a source water protection plan available from our office that provides more information such as potential sources of contamination.

If you any questions about this report or concerning your water utility, please contact the park manager, Wanda Winn, at 28455 S.W. Boones Ferry Rd #A, Wilsonville, Or, 97070 (503-682-9002). Our water samples are tested through Alexin Analytical Labs, in Tigard, OR. (503-639-9311), we want our valued customers to be informed about their water utility.

All sources of drinking water are subject to potential contamination by substances that are naturally occurring or man-made. These substances can be microbes, inorganic or organic, chemicals and radio-active substances. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk.
