SETTLEMENT AGREEMENT AND FINAL ORDER

The Oregon Health Authority, Public Health Division, Center for Health Protection, Drinking Water Services (Authority) issued a Notice of Violation and Administrative Order on March 9, 2017 (Order) requiring action to ensure safe drinking water at the City of Monument (Monument) water system due to alleged violations of the Oregon Drinking Water Quality Act (ORS 448.115 to ORS 448.290) and Oregon Administrative Rules. The City requested a hearing on March 16, 2017.

The Authority and the City agree to resolve the matter of the Order (including all violations related thereto) by stipulating as follows:

- Agreement Article No. 1: The City shall submit to the Authority, as specified in Compliance Action No. 1 in the Order, complete construction plans identifying a new water source or water treatment to be installed at the Monument water system. The plans shall be submitted to the Authority no later than January 1, 2019.
- Agreement Article No. 2: The City shall complete Compliance Actions No. 2 through 5, which remain in full force and effect, as specified in the Order. To this end, the City will complete construction and installation of the new water source or water treatment at the Monument water system within 12 months after the Authority grants conditional approval of the City's construction plans submitted according to Agreement Article No. 1 in this settlement.

- Agreement Article No. 3: The City waives all rights to a contested case hearing or any judicial review of the Order.
- Agreement Article No. 4: Provided the City complies with the terms and deadlines specified in this settlement and final order, the Authority will not take any enforcement actions related to the Order (including all violations related thereto).
