RE: Extension to the Bilateral Compliance Agreement Between the Oregon Health Authority and Watseco-Barview Water District

The Watseco-Barview Water District (District) entered into a bilateral compliance agreement with the Oregon Health Authority, Public Health Division, Center for Health Protection, Drinking Water Services (DWS) on July 17, 2013 in order to ensure compliance at the Watseco-Barview water system, identified by PWS ID# 4101173.

The agreement set forth actions to be completed by the District to comply with the maximum contaminant level for total trihalomethanes. Specifically, the District agreed to receive drinking water from the City of Garibaldi through an intertie. The intertie project was not completed according to schedule due to circumstances beyond the control of either the City of Garibaldi or the District.

Based on the progress to satisfy the terms of the agreement, DWS agrees to an extension as specified below.

## TERMS OF THE EXTENSION

- The District will demonstrate that the intertie between the Watseco-Barview water system and the City of Garibaldi water system is fully operational and available for use no later than November 1, 2015 or within one month of completing construction of the project, whichever comes first.
- The District will, if necessary, publish public notice for exceeding the MCL for total trihalomethanes as specified by OAR 333-061-0042. The notice will meet all of the applicable requirements of OAR 333-061-0042(4) and a copy will be submitted to DWS, including certification of the method of distribution, no later than 10 days after completing the public notification according to OAR 333-061-0040(1)(i).

• DWS and the District agree that this extension supersedes and replaces the Bilateral Compliance Agreement that was effective between the parties after being signed by DWS on July 31, 2013.

This extension does not constitute a waiver, modification, or suspension of the requirements of the Oregon Drinking Water Quality Act; ORS 448.115 to 448.285 and administrative rules OAR 333-061-0005 to 333-061-0290, which remain in full force and effect.
