


On February 12, 2025 our office received coliform sample results and a completed *Project Final Approval Request Form* (enclosed) confirming that the above project was completed April 1, 2021 according to the plans submitted and conditions set forth in the <u>May 13, 2020 Conditional Approval</u> letter.

On April 30, 2020, our office received a set of plans. A plan review fee of \$3,300 and a land use compatibility statement were received on May 4, 2020. The project included installation of 8" and 12" C900 waterline and associated appurtenances in the Hoffman Meadows Subdivision. A Conditional Approval letter was issued by Carrie Gentry on May 13, 2020.



Per the completed *Project Final Approval Request Form* signed 2-12-25, there were no differences in what was shown on the plans originally submitted and what was installed. Coliform sample results taken 2-24-21 were absent of coliform bacteria and the facilities were placed into operation on 4-1-21.
