d. **DENIAL OF PERMIT.** If the application does not conform to the requirements of this Ordinance or the regulations or standards for the maintenance, operation, or use of the City Water System, the Manager shall deny the permit.

e. **DURATION OF PERMIT.** The permits issued by the Water Department shall be valid for one (1) year. The permittee shall complete the development authorized by the permit before the expiration date on the permit. The Manager shall cancel the permit if the development has not been completed within the one-year time limitation. Cancelled permits shall not be re-validated; a new application and permit is required if the development is not completed prior to the expiration date on the permit.

9.60. CANCELLATION OF APPROVED PERMITS. Approved permits may be cancelled by the permittee and development fees may be refunded to the permittee provided that:

a. A written notice is filed with the Manager requesting cancellation of the permit, and

b. No development of any kind has begun either by the permittee or Water Department.

SECTION 10. CONNECTIONS.

10.10. COMPLIANCE WITH BUILDING CODES. All new or altered customer service pipe shall be installed, maintained, and altered in compliance with the State of Oregon Building Codes.

10.20. CROSS CONNECTIONS. No person shall cross connect the City Water System and any source of water that is not part of the City Water System.

10.30. BACK FLOW PREVENTION DEVICES.

a. **COMPLIANCE WITH HEALTH DIVISION REGULATIONS.** All existing customer service pipe and all new connections shall comply with back flow prevention regulations of the Oregon State Health Division.

b. **INSTALLATION REQUIRED UNDER SPECIAL CIRCUMSTANCES.** The Manager may require any City Water user, even if the use is not regulated by the Oregon State Health Division, to install back flow prevention devices upon a finding by the Manager that water use practices, land use practices, or the design, construction or use of the customer service pipe or plumbing systems at the place of use create an extraordinary risk of contamination of the City Water System due to actual or potential cross connection.

SECTION 10. CONNECTIONS.

10.10. COMPLIANCE WITH BUILDING CODES. All new or altered customer service pipe shall be installed, maintained, and altered in compliance with the State of Oregon Building Codes.

10.20. CROSS CONNECTIONS. No person shall cross connect the City Water System and any source of water that is not part of the City Water System.

10.30. BACK FLOW PREVENTION DEVICES.

a. **COMPLIANCE WITH HEALTH DIVISION REGULATIONS.** All existing customer service pipe and all new connections shall comply with back flow prevention regulations of the Oregon State Health Division.

b. **INSTALLATION REQUIRED UNDER SPECIAL CIRCUMSTANCES.** The Manager may require any City Water user, even if the use is not regulated by the Oregon State Health Division, to install back flow prevention devices upon a finding by the Manager that water use practices, land use practices, or the design, construction or use of the customer service pipe or plumbing systems at the place of use create an extraordinary risk of contamination of the City Water System due to actual or potential cross connection.

c. **REQUIRED IN FLOOD HAZARD AREAS.** In the Flood Hazard Area, as defined in the Adams Zoning Ordinance, a backflow prevention device shall be installed on all new connections and reconstructions of customer service pipes.

d. **COST OF INSTALLATION AND MAINTENANCE.** The property owner shall be responsible for paying all costs of installation and maintenance of back flow prevention devices that are required in Section 10.30 of this Ordinance.

e. **INSTALLATION AND MAINTENANCE STANDARDS.** Back flow prevention devices required under Section 10.30 shall be installed and maintained in accordance with standards set forth by the Manager.

SECTION 11. CUSTOMER SERVICE PIPE.

11.10. **INSTALLATION AND MAINTENANCE.** Customers shall install and maintain their Customer Service Pipe and plumbing systems in accordance with the State of Oregon Building Codes.

11.20. **TEMPORARY SHUT OFF OF WATER.** When any new Customer Service Pipe is installed at any place of use, the service cock in the meter box shall be closed and thereafter will be opened only by the Water Department and only after a written request is submitted to the Water Department by the property owner or the property owner's agent.

11.30. **SHUT OFF OF WATER SUPPLY.** Any person other than the Manager or the Managers designee, called upon to shut off water and drain pipes at any place of use shall do so only on the discharge side of the meter.

11.40. CUSTOMER SERVICE VALVE.

a. **RECONSTRUCTION.** Reconstruction of any portion of the customer service pipe that replaces all or part of the pipe connecting to the meter, shall, in all cases, include the installation of a customer service valve that is approved by the Manager. The valve shall be installed such that it can be operated through direct access from the ground surface. The owner or customer shall pay the cost of the valve and installation.

b. **NEW INSTALLATIONS.** New installations of any portion of the Customer Service Pipe that connects to the meter shall, in all cases, include the installation of a Customer Service Valve approved by the Manager.

11.50. **SWIMMING POOLS.** Swimming pools, wading pools or other such devices that are permanently connected to the City Water System shall be constructed (1) so that the conduit or pipes supplying water from the City Water System at the point of outlet

of the supply conduit or pipes, shall be at least one foot above the top of the pool curb or deck; or (2) with a back flow prevention device approved by the State of Oregon Building Codes and Manager.

11.60. DRAINAGE USING SIPHON OR INJECTION TYPE PUMPS. No person shall install, maintain or use any water siphon or injection type pump operated for drainage purposes which connects to and uses the water supply from the City Water System.

11.70. LAWN OR GARDEN SPRINKLING SYSTEMS.

a. SIPHON BREAKER REQUIRED. Customer service pipes leading to lawn or garden sprinkling systems and drawing its water supply from the City Water System shall contain a siphon breaker to prevent back siphoning of water that may be standing on the lawn in the case of interruption of service. Such devices shall be regularly inspected by the customer and shall be repaired or replaced whenever they are found to be defective and all costs of inspection, repair and maintenance shall be borne by the customer.

b. COMPLIANCE WITH STATE CODE. All installations shall comply with the provisions of this Ordinance and with the State of Oregon Building Codes concerning lawn sprinkling systems.

SECTION 12. WATER MAINS.

12.10. CONTROL. The water mains of the City shall be under control of the Manager and no person or persons other than the Manager or the Managers designees may tap, alter, obstruct or interfere with the mains or in any way disrupt or alter the water flow or quality in the Water System.

12.20. EXTENSIONS.

a. COUNCIL CONTROL. Extensions to water mains may be made upon proper petition and approval of the Council or by initiative of the Council. The Council shall have the authority to reject such petitions or to enter into any contract with the petitioners as the Council may elect.

b. LOCATION. The Water Department will make water main extensions only on rights-of-way, easements or publicly owned property. Easements or permits secured for main extensions shall be obtained in the name of the City of Adams, along with all rights and title to the main at the time the service is provided to the customer paying for the extensions.
